If you or your advisor have concerns about publishing your abstract, we recommended that you edit it to remove the information you are concerned about making public. Abstract information is an important tool for scholars to learn about the research taking place in their fields, and abstracts of dissertations in particular is a way to communicate where early stage researchers are moving their fields. Of course, if in the end you are convinced that embargoing your abstract is the best option, then we will implement your choice as indicated on your submission form and in your ETD record.</p> <p><b>You will be notified by the library sixty (60) days prior to the expiration of the restricted period that your thesis or dissertation will be published on the internet.
